Changes that employees may make during Open Enrollment include:

- Enroll in a new plan (i.e. Change from Basic to High Medical Option)
- Add/Drop a spouse/dependent(s) to your plan (Legal documentation & SSN is required)
- Re-enroll in the Flexible Spending Accounts (FSA)
- Update Beneficiaries

Open Enrollment Highlights-Please refer to PowerPoint for further details

- While the medical plans are remaining the same, there will be a slight increase in the rates.
- · Your benefit year will now coincide with a calendar year
- Health Care Flexible Spending Account (FSA) Annual Maximum Increases to \$2,550 and New \$500 Rollover Provision for Health Care FSA
- REMINDER: Benefits coverage ends at midnight on the last day of an employee's active employment date.

Making Open Enrollment Changes

- No changes? Simply do nothing. PLEASE <u>DO NOT TURN IN ANY ENROLLMENT</u> FORMS
 - If you are not changing any of your elections or are not adding/dropping any dependent(s), you do not have to do anything and your elections will remain the same in 2016 (with the exception of FSA, you must re-enroll in FSA for 2016).
 - Revised deduction amounts will begin on your paycheck on January 8, 2016.
- Making changes to your elections? First time enrollees? Terminating coverage? Re-Enrolling in FSA?
 - If you are making changes to your elections or enrolling for the first time, you must complete the open enrollment form and "Submit" it on or before November 13, 2015 via E-Mail to the secure benefits mailbox: benefits@msm.edu
 - To Submit Enrollment Form, fill in form electronically, click on "Submit" button then complete
 email address and name. Select "Desktop Email" as Email Client and Click "Ok". Lastly,
 Click "Ok" for "Outgoing Message Notification".

- If you elected FSA (Medical and/or Dependent Care) in 2015, you are required to re-enroll for 2016.
- If you are adding a spouse/dependent(s) you must complete a new enrollment form, provide legal documentation (Marriage License or Birth Certificate, etc.) and submit via email to the secure benefits mailbox: benefits@msm.edu on or before November 13, 2015.

DEADLINE: Submit forms No later than 5pm on Friday, November 13, 2015.

- Any benefits change forms received after this time will not be accepted.
- Complete and Submit Open Enrollment Forms and Supporting Documentation via E-Mail to the secure benefits mailbox: <u>benefits@msm.edu</u>. Forms submitted via any other method will NOT be accepted.
